



## Supplemental Benefits - HMO-POS

**Vision care. BSW SeniorCare Advantage** plans include a routine annual exam, plus an annual allowance toward the purchase of contacts, frames and lenses. You can visit an in-network or out-of-network provider—the choice is yours. If you use an out-of-network provider, your share of the costs for your covered services may be higher.

**Hearing care.** We offer essential hearing services that are not covered by Original Medicare, including a routine hearing exam and an allowance every three years toward the purchase of hearing aids. You may visit any provider—in or out of network—for routine hearing exams, as well as hearing aid fitting and evaluation. If you use an out-of-network provider, your share of the costs for your covered services may be higher. You may use your hearing aid allowance at any provider, too.

**Over-the-counter allowance.** BSW SeniorCare Advantage plans feature a quarterly purchase allowance (based on calendar quarter) from participating retailers to purchase eligible over-the-counter items, such as bandages, cold and allergy medicines, pain relievers, and more.

**No-cost fitness program.** Through Silver&Fit®, plans include a no-cost fitness membership at participating locations, like the YMCA and more.

**In-home meals.** Plans include a meal benefit to ease your recovery when you return home from the hospital–14 meals per hospital discharge to home; limit 3 discharges per year.

**Routine transportation.** Plans include routine transportation to approved locations such as medical appointments, physical therapy visits, labs, grocery stores and drug stores.

**Dental care.** Plans include dental coverage through MetLife with maximum **benefits up to \$3,500** with thousands of providers to choose from. Coverage includes things like exams, cleanings, X-rays, extractions and fillings, restorative services and even dentures.
