What is the overall deductible?	\$1,000 per member / \$2,000 per family for a participating provider and \$2,000 per member / \$4,000 per family for a non-participating provider .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible?	Yes. Preventive care is covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. \$100 deductible for participating provider and \$150 deductible for non-participating provider prescription drug coverage. What is the out-of-pocket limit for this plan?	\$6,000 per member / \$12,000 per family for a participating provider and \$12,000 per member / \$24,000 per family for a non-participating provider .	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
